1. Be a current competitive USFA member. (Expiration year 2007 or later), **Proof is required at check-in**
2. U-19 Events: the fencer must have a birth year in 1988 through 1994
3. Senior Events: the fencer must have a birth year of 1993 or earlier.
4. Must be a member of one of the following divisions: Alabama, Central FL, Gateway FL, Georgia, Gold Coast FL, N. Carolina, S. Carolina, Tennessee, or Virginia.

All participants **MUST** read each of the following statements and then sign at the bottom where indicated (for athletes under the age of 18, a parent or guardian must also sign)

**WAIVER OF LIABILITY:** Upon entering the SES championships, I agree to abide by the current rules of the USFA. I understand and appreciate that participation in sport carries a risk to me of serious injury, including permanent paralysis or death. I voluntarily and knowingly recognize, accept and assume these risks and release the USFA, the Southeast Section, the event organizers, their representatives and the venue operators from any liability.
